GENERAL INFORMATION

AquaPlex amino supplies readily available calcium and amino acids to regulate osmotic potential and help turfgrass tolerate stressful growing conditions.

USE RATES

AquaPlex amino can be applied to all turfgrass impacted by salt stress including golf course greens, fairways and roughs, sports and landscape turf.

Golf Course Greens

Apply AquaPlex amino at the onset of salt related stress. Repeat application every 2-4 weeks depending on severity of stress. Apply 1.5 gallons of AquaPlex amino with a spray volume of 50 gallons of water per acre.

Fairways, roughs, sports and landscape turf

Apply AquaPlex amino at the onset of salt related stress. Repeat application every 2-4 weeks depending on severity of stress. Apply 1.5 gallons of AquaPlex amino with a spray volume of 30-40 gallons of water per acre.

STORAGE AND DISPOSAL

- Store in a cool, dry place. Store in original container. Keep container tightly closed. Do not contaminate water, food or feed by storage or disposal.
