AquaGro 2000 M is recommended for use by substrate producers in soilless growing media to aid in wetting of the substrate.

DIRECTIONS FOR USE

Apply AquaGro 2000 M at 2 to 8 ounces per cubic yard (78 to 310 ml per cubic meter) of substrate to ensure desirable wetting of substrate.

STORAGE AND DISPOSAL

- · Keep container tightly closed. Store in original container only. Keep in a secure and locked storage area. Do not add water to the contents of this container.
